These deposits are protected under the Luxembourg FGDL scheme (see below) to a value of €100,000 per investor. In the interests of diversifying the risk we may invest a proportion or all of the pooled money in a country outside of Luxembourg. This does not affect your deposit protection under the FGDL scheme.

Internaxx Bank S.A. may deposit all client monies within the Interactive Investors Group when specifically allowed under European Union banking regulation.
